DEPARTURE GUIDE

- Click [here](#) to check if you are allowed to travel within the Philippines.
- Ensure that all requirements (*negative test result, vaccination card/certificate, etc.*) are met before booking your domestic destination. Check this [link](#) for some guidelines but it is advisable to call you destination's Local Government Unit (LGU) as there may be additional requirements.
- For *Philippine Airlines (PAL)* passengers, you are required to register and accomplish the *Passenger Profile and Health Declaration (PPHD) Form* and save the *confirmation email* and *QR code*.
- For passengers with stop overs in their flights, secure required travel and health documents for all stop overs, until your final point of arrival.
- Download the *TRAZE mobile app* and complete registration. The app will also provide another *unique QR code* to utilize in any of the Philippine airports.

AIRPORT GUIDE

- Arrive in the airport at least 2 hours before your scheduled departure. This is to accommodate the additional security screening implemented in the airport terminals or at the pre-departure area.
- Only passengers with confirmed bookings are allowed to enter the airport.
- Undergo documentation check at the airport. The documents checker shall assess the completeness and validity of your documents. You may not be able to check in and board the flight if you miss any of the requirements.
- Passengers are encourage to bring their own sanitation/disinfection kit and personal pen to fill-out forms.
- Passengers shall strictly observe the following upon entering the airport and boarding the aircraft:
 - Mandatory wearing of face mask and face shield.
 - Mandatory temperature check, use of foot baths, and disinfection/sanitation facilities.
 - Mandatory physical/social distancing and minimum contact at all times.
 - Mandatory public safety announcement.
 - Compliance to safety procedures at all times.
